



TERMS OF REFERENCE FOR THE PROCUREMENT OF TWO (2) UNITS OF MOTOR VEHICLES FOR THE PRESIDENTIAL COMMISSION ON GOOD GOVERNMENT (PCGG) FOR FY 2024

1.0 Rationale

The PCGG through its Bids and Awards Committee (BAC) will undertake the procurement through public bidding of Two (2) units of Motor Vehicles in accordance with its Vehicle Re-fleeting Program.

2.0 Objective

The objective of the procurement is to provide the Commission with efficient and economical motor vehicles based on government prescribed technical specifications to replace its ageing motor vehicles and to efficiently discharge its functions.

3.0 Approved Budget for the Contract

The Approved Budget for the Contract (ABC) is **TWO MILLION SEVEN HUNDRED THOUSAND PESOS (PHP 2,700,000.00)** for two (2) units of motor vehicles inclusive of all applicable taxes. The ABC will be sourced from the General Appropriations Act of 2024.

5.0 Other Requirements

5.1 On Unit

- 5.1.a Availability of spare parts nationwide
- 5.1.b Free labor on preventive maintenance service within the first 10,000 (Minimum) kilometers check-up/change oil
- 5.1.c With mag wheels and seat cover
- 5.1.d Rust proofing/undercoating
- 5.1.e Basic tool kit with complete set of tools, new spare tire, early warning device, tint, floor matting and rain visors.
- 5.1.f Vehicles should be of the same manufacturer
- 5.1.g Free LTO registration for the first three (3) years
- 5.1.h Certification accompanied with verifiable proof that the brand being offered has been in the Philippine Market for at least FIFTEEN (15) YEARS.

5.2 On Dealers

- 5.2.a Must be at least ten (10) years in the business as authorized dealer of brand new vehicle
- 5.2.c Must have service centers nationwide.
- 5.2.d With free 1 year CTPL.

6.0 Warranty

Minimum of Three (3) years or 100,000 kilometers whichever comes first, on both parts and labor.







7.0 Delivery Terms

The delivery period shall be within thirty (30) calendar days upon receipt of the Notice to Proceed (NTP) and delivery address shall be at:

8.0 Payment Terms

The payment shall be within thirty (30) calendar days after complete delivery and written acceptance of the deliverables by the PCGG Administrative Services Division.

The PCGG reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract pursuant to Section 41 of the 2016 Revised IRR of RA 9184.
