WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the Government Procurement Reform Act, the Bids and Awards Committee (BAC) conducted competitive bidding for the procurement of two (2) units of Motor Vehicles for FY 2024 under Procurement Project No. 2024-001 with Approved Budget for the Contract (ABC) of P1,200,000.00 for Lot 1 and P1,500,000.00 for Lot 2, respectively;

WHEREAS, during the preliminary examination and opening of bids on 15 July 2024, no bidder submitted its bid;

WHEREAS, as a result thereof, the BAC resolved to declare a failure of bidding;

No. 9184;

WHEREAS, the TWG has verified all the legal, financial, and technical documents submitted by TOYOTA OTIS, INC., and found them to be in order;


WHEREAS, based on the results of the post-qualification, TOYOTA OTIS, INC., has met all the legal, financial, and technical requirements of the procurement.


